Academic Affairs – Blake Goforth

Academic Affairs teams resume meeting in August with activity to include the development of A2100.05 Program/Major Pathway Development; A2100.20 Course Development; A2100.60 Academic Program Review; and 2300.30 Faculty Evaluation.

The agenda includes three policies for review. Also, Student Affairs teams are working on a SAP policy and will be conducting several Enrollment Extravaganza events over the next few weeks.

There have been no recent meetings, however Felicia has been gathering information/input via electronic means and the next policy to develop is personal safety/wellness. A. Pursuit of Excellence in Admissions & Records Practice (A3100) SECOND READ
